(Pacific) Clauses (appendix D). On the east coast, the London Institute Time Clauses seem to be  
preferred. Great Lakes fleets are generally insured under the Canadian Board of Marine

American Institute Hull Clauses - Blue Seas Adjusters

Lines 134/139 of the American Institute Hull Clauses (June 2, 1977) reads as follows: TOTAL LOSS In ascertaining whether the Vessel is a constructive Total Loss the Agreed Value shall be taken as the repaired value and nothing in respect of the damaged or break-up value of the Vessel or wreck shall be taken into account.

American Institute Clauses Hull Clauses 1977

American Institute Hull Clauses (AIHC) A hull insurance form that is commonly used in the U.S.; covers particular average or total loss of the insured vessel, sue and labor expenses, general average and salvage, and the assured's liability for collision damage to other vessels and their cargoes.

The five limits provided under the American Institute Underwriter's Risk coverage form are as follows: 1. Total Loss of the vessel The "Total Loss" clause of the American Institute Underwriter's Risks clauses (lines 84 to 94) is self explanatory.

### American Institute of Marine Underwriters AIMU - Marine ...

The American Institute's Hull Clause for the Return of Premium will apply if a vessel has been laid up in port not under repair, and not used for storage. The premium will be returned for Each 30-day period.
