The Trade Act of 1974, passed after Nixon resigned, initiated what is now known as trade promotion authority, or "fast track," circumventing the normal legislative process. The president got to pick trade partners, launch negotiations, sign agreements, and get an up-or-down vote in Congress within 90 days, with no committee markups, no amendments or filibusters, and strictly limited debate.
