If you suffer from a medical condition that is unlikely to change within a year, and this condition prevents you from serving jury duty, you must submit a doctor's note indicating that you are unable to perform jury duty. The doctor's note must be written on your doctor's letterhead and signed by your doctor.

If you have a permanent medical disability, your letter should also state that your condition is permanent, and that you'll never be able to serve jury duty. Your practitioner should review the information for medical disqualification before deciding whether you're capable of performing jury service.

A jury must be specifically instructed on the duties of a physician in this context. Merely giving abstract instructions on negligence without adapting the instruction to the duties present in the case is error. Mikkelsen, 764 P.2d at 1388, citing Everts v. Worrell, 197 P. 1043, 1046 (Utah 1921).
