Clarke's First Law. In 1962, Clarke published a collection of essays, *Profiles of the Future*, which included an essay called "Hazards of Prophecy: The Failure of Imagination." The first law was mentioned in the essay although since it was the only law mentioned at the time, it was called just "Clarke's Law":
