What Are “Case Studies”? There are 2 types: “Take-Home” Case Studies – You get an extended period (a few days to a week) to work on these, complete your analysis, and then present your findings. “On the Spot” Case Studies – You do these on the spot at interviews or at assessment centers and you only have 1-2 hours to create a coherent presentation. Usually the case study centers on a question such as: Company X wants to acquire one of these 3 companies.
