CE requirements: Resident producers licensed for major lines of authority (life, health, property, casualty, personal lines) or title must meet the CE requirement before they can renew. Verify your resident CE. Nonresident producers must hold comparable lines of authority in their resident state as they do in Missouri to renew electronically.

It is unlawful for any person to transact the business of title insurance unless they are authorized as a title insurer, title agency or title agent and duly licensed business entity insurance producer; it is unlawful for any title insurer to contract with any person to act in the capacity of a title agency if that person is not duly licensed.
