## **The Muslim Family Laws Ordinance 1961**

In the *izhar* (or *ḡihār*) oath a man declares that his wife is as sexually prohibited to him as his mother. The husband is able to break the oath and resume the marriage. Breaking either oath requires expiation by means of feeding the poor or fasting. In the *li'an* oath, the husband denies paternity of his wife's child.
