The complaint should follow what is known as "notice pleading." This requires that you provide a "short and plain statement" of a claim, except for "fraud or mistake" which require "particularized" allegations.

Do you cite case law in the initial complaint when filing ...

On the left side of the pleading paper, state the full name of the plaintiff in the case. On the next line, type the word "Plaintiff." Space down two lines and type a "v" which is an abbreviation for the word "versus." Double space one more time and state the full name of the defendant.

Plaintiffs must ensure that their complaints include sufficient factual specificity. Wherever possible, plaintiffs should attach their insurance policy (including the policy's declarations page) and all significant correspondence regarding the claim to the complaint.
