The Act also temporarily suspends involuntary collection of covered loans—no wage garnishments, tax intercepts, offset of federal benefits, or any other collection activity will occur through September 30, 2020. See § 3513(d), (e). Covered borrowers will be provided notices of all of these rights within fifteen days of the CARES Act's March 27th enactment.
