A chapter 7 bankruptcy case does not involve the filing of a plan of repayment as in chapter 13. Instead, the bankruptcy trustee gathers and sells the debtor's nonexempt assets and uses the proceeds of such assets to pay holders of claims (creditors) in accordance with the provisions of the Bankruptcy Code.

A Chapter 7 bankruptcy will generally discharge your unsecured debts, such as credit card debt, medical bills and unsecured personal loans. The court will discharge these debts at the end of the process, generally about four to six months after you start. Some types of unsecured debts usually aren't discharged through a Chapter 7 bankruptcy, including: Child support; Alimony; Student loans; Some tax debt

What Is Chapter 7?

Individuals may file Chapter 7 or Chapter 13 bankruptcy, depending on the specifics of their situation.

Municipalities—cities, towns, villages, taxing districts, municipal utilities, and school districts may file under Chapter 9 to reorganize. Businesses may file bankruptcy under Chapter 7 to liquidate or Chapter 11 to reorganize.

The trustee then liquidates or sells your property, not protected by law, to pay back your creditors. If your debt ends up exceeding your assets, the court forgives it.
