Under section 69 of the Women's Charter, any married woman whose husband fails to provide her reasonable maintenance may apply for her maintenance of either a monthly allowance or a lump sum to the Court. Divorce cannot be filed within 3 years of a marriage and can only be for the sole reason that marriage has irretrievably broken down.
